Dear Past Council Chairperson Rigo,

As I'm sure you understand, my response is restricted to matters governed under the International Constitution and By-Laws and other governing documents of the association. As there is no "official candidate" or "sole candidate" recognized by the association, I am only able to confirm that all certified candidates are permitted to run for office, and may be selected by certified delegates in attendance at an international convention.

Additionally, as required in the International By-Laws, Article II, Section 6, the election of all international officers shall require a plurality vote in order to be elected. As provided in policy, no candidate has a "guaranteed election", and all certified candidates are required to obtain a plurality of votes.

As I'm sure you are aware, there are no guidelines for third vice president candidates on how they choose to campaign, and the association is not involved in local campaigns of any endorsed or certified candidates. However, should the International Board of Directors determine additional guidance be provided to candidates to ensure compliance with the association's Code of Ethics, I trust the board will take action as necessary.

Article II – International Elections

Section 4 – Certification Requirements

Item a)

During the term of validity of endorsement, (i) no rescission shall occur, (ii) no other endorsement is valid, and (iii) in the event of death, ineligibility, withdrawal of the candidate, the original resolution of endorsement is null and void. No further cer-
